SUBJECT	:	Research Requires RGAO Registration (RRRR)

All researches undertaken by the UP Manila faculty, staff, and students should be registered with the UPM Research Grants and Administration Office (RGAO). This can be done electronically through: <a href="https://rgao.upm.edu.ph/registration/">https://rgao.upm.edu.ph/registration/</a>.

The registration of research proposals and projects with RGAO can be done at any stage – whether it is in the proposal stage, midway into its implementation, after its completion, or after publication or presentation. There is no penalty for late registration.

The table below provides checkpoints at which UPM researchers can be reminded to register their researches:

Benefits of RGAO registration to the researcher:

- 1. prerequisite for ethical review of research proposal by REB, IACUC or IBBC
- 2. eligibility of research proposal for research grants
- 3. assurance that research is officially listed as a scientific and intellectual output of the UP
- 4. eligibility of output for research dissemination grants and publication awards
- 5. eligibility of output for intellectual property applications
- 6. researcher eligibility for promotion, awards, One UP Professorial Chair, One UP Faculty Grant, Scientific Productivity System and performance-based bonuses

Benefits of RGAO registration to the University:

- 1. maintenance of a complete and official UPM repository of research data
- 2. assurance that all research of UPM constituents is accounted for
- 3. identification of personnel and units involved in research
- 4. accurate accounting of UPM research income
- 5. qualitative and quantitative overview of research productivity of UPM constituents and units (e.g. topics, alignment with National Unified Health Research Agenda and UN Sustainable Development Goals)
- 6. access to performance-based bonus (PBB)
- 7. timely and complete submissions for evaluation of University compliance, ranking, and competitiveness by both local and international monitoring agencies

Only RGAO registered researches should be accepted for:

- course and training requirement compliance;
- staff promotion, award nominations, and grant applications.
